The Purchaser agrees to pay the balance in cash, at the time of pickup, at which point the cat/kitten described will be released to the new owner. Said kitten/cat is being held for the purchaser and will not be sold to any other buyer, regardless. A breach of contract, either verbal, written or through neglect or avoidance to communicate, on Purchaser's part can jeopardize the chance of finding said kitten/cat a new home as quickly as possible. Therefore, the waiting list deposit of \$ _____ is not refundable should the Purchaser for any reason change his/her mind about purchasing said kitten/cat. The additional payment of \$ _____ will be refunded to the Purchaser if the Seller fails to, make available the above said kitten/cat to Purchaser. However, Seller reserves the option to offer a kitten/cat and Purchaser is intuted to accept or decline.

Kittens are ready to leave the cattery at twelve to fourteen weeks of age. The anticipated date for surgery and release of this kitten is _____. Should the buyer request that the kitten be held for a period beyond 7 days after this time, a boarding charge of \$10 per day will be accrued, unless specific arrangements to the contrary have been made between parties. In any case, final payment is due upon pick up or within one week post-surgery,(date)_____. Failure to pay in full for the kitten by that time, will result in loss of deposit by Buyer and Seller shall then be free to place the kitten with another buyer

Occasionally, a kitten or litter needs additional time to develop, and Indian Creek reserves to right to delay the surgery and release of the kitten until they feel it is safe for the kitten to go to its new home. Every effort is made to anticipate any delay and to notify the Purchaser. However, some events are not foreseeable.

If shipping is required, Buyer is responsible for all shipping related expenses (airline fees, appropriate carrier, health certificate, etc) which will be no less than \$300. If transportation is necessary by car, costs will be a minimum of \$25 plus necessary related round trip expenses (gas, tolls, parking, lodging, etc). The Buyer, by signing this contract, has reviewed, understood, had a chance to question and has accepted this contract in its entirety.

Any disagreements resulting from the purchase of this cat will not be published by buyer, seller or their associates on social media or on any internet sites. Damages for violation of this clause will be \$5,000.

This contract is legally binding on the buyer(s) and seller in this transaction and is non-transferable to other parties. Signing indicates agreement to this contract. Breach of contract will result in cancellation without compensation. Jurisdiction of this contract will be the municipality of the Sellers residence at the time of dispute. Buyer shall be liable to Breeder for any and all legal fees incurred in the enforcement of contract.
